



# INTERNATIONAL SHOOTING CHAMPIONSHIP IPA-LIPOCAT TARRAGONA 2024

## **KEY POINTS:**

# 1.- Participants.

Open to active or retired Security Forces and Armed Forces members.

# <u>2.- Teams.</u>

In order to participate in the league, teams must adhere to the following criteria:

- Comprised of three shooters, who may belong to:
  - Security Forces:
    - Local Police from the same town.
    - Local Police from towns with a population of less than 15000, are allowed to form teams per town.
  - Members of the Security Forces who are retired or on leave.
  - Armed Forces from the same town.
- Mixed teams are prohibited outside of the specified parameters.

Team captains are responsible for ensuring that their members possess the necessary knowledge and skills to perform without endangering themselves or others. Captains must enforce compliance with security rules and proper weapon handling.

#### 3.- Development of the competition.

The competition consists of four practical shooting exercises (IPSC) and the scores achieved in these exercises will contribute to the final individual and team rankings.

Shooters will be organized into four squads, and each squad member will participate in one of the exercises. When one exercise is finalized, the squads will rotate to the next one until all four exercises have been completed.

To expedite and simplify the exercises, it is mandatory for the two shooters preceding the competitor to be responsible for patching. Any shooter failing to adhere to the patching rule when required will receive a procedural error mark in the respective exercise.

# 4.- Categories and Trophies.

- General: top three individual finishers.
- Teams: the first three classified teams.
- Females: the top classified female participant
- Veteran: the top classified veteran participant
- Super veteran: the top classified super veteran participant.

#### 5.- Classification.

An overall individual general classification will be compiled, with one classification per category and one per team, on the accumulative scores obtained by the three members of each team.

#### 6.- Calendar.

The competition is scheduled for **June 18th of 2024** at the Jordi Tarragó Shooting Club facilities in Tarragona.

Registration, confirmation and verification of all documentation related to shooters and weapons will start at 08:30 a.m. The competition is set to begin at 10:00 a.m.

## 7.- Armament.

The same weapon will be utilized for all exercises. A permissible weapon is defined as one that, due to its configuration, dimensions and characteristics, can be used in daily duty and in any case falls within the IPSC production category.

Orthopedic or anatomical grips, muzzle brakes, compensators, counterweights, or other modifications deemed as competition features are not allowed.

Ammunition for the exercises will be 9mm PB and the organization may conduct factor tests in accordance with IPSC regulations.

A minimum of 120 cartridges will be required to complete all exercises.

Magazines must be loaded with a maximum of 15 cartridges and each participant must carry at least two magazines.


Magazine holders must be constructed of material that securely retains and covers the magazine for a minimum of one third ( $\frac{1}{3}$ ) of its length. The use of any magnet or similar device providing an advantage in handling the magazine is not permitted.

Weapon holster must not incorporate mechanisms that facilitates the extraction, and the weapon's trigger should not be visible.

Quick-release IPSC covers are explicitly prohibited. Only covers meeting service standards, as defined by their configuration and appearance, will be accepted. They must be waist holsters and cross extraction is not allowed.

#### 8.- Targets.

The targets utilized for the competition will include regulatory cards for IPSC, metallic targets and police silhouettes.



# 9.- Regulations and standards.

An arbitration committee will be established, comprising three officials (one from the organizing body and two from other championships). They primary function will be to conduct checks and verifications of weapons, ammunition, final scoring and address any potential claims.

The rules for the exercises will adhere to those currently enforced by IPSC. For safety considerations and to facilitate the exercises, the organization may implement specific rules, particularly in terms of safety:

- Firearms must remain within the designated shooting areas. Inside these areas, firearms should be unloaded, without a magazine, and secured in their holsters.
- During exercises, all handling and reloading of firearms must be conducted with the barrel pointed toward the target area, respecting the 90° safety angle in relation to the targets.
- The referee or judge will communicate the procedure, arrangements, and the use of the weapon during the exercise to the shooter.
- Only the shooter or persons authorized by the referee or judge are allowed in the shooting gallery.
- Firearms without ammunition may only be manipulated in the designated area known as the "cold zone" or "safety zone".

#### 10.- Scores and Penalties.

The scoring system outline in the existing IPSC regulations will be adhered to.

Shooters failing to comply with safety regulations and thereby jeopardizing the safety of individuals and/or facilities may face disqualification.

#### 11.- Observations:

Maximum number of participants: 60 strictly in order of registration.

#### Date: June 18th of 2024

#### Last day for registration: June 11th of 2024, at 23:59.

It is mandatory to possess the federative license of the Olympic Shooting Federation. For those shooters without the corresponding license, the organization will facilitate a temporary license for one day, covering the duration of the event.

Any incidents or doubts arising during the competition will initially be addressed by the shoot's referee. Matters beyond their purview will be taken to the Delegates or Team Captains for resolution, decided by majority agreement, with federative rules prevailing if specified.

Participants, including members of the Local Police and Security Forces and Corps, are reminded of their obligation to report any weapon interventions by the Guardia Civil, as well as the movement of regulatory weapons outside the municipal area if used in the Championship. Shooters are responsible for ensuring all their documentation and that of their weapons is in order, without which they will be ineligible to participate in the competition.

Before start each exercise, the respective referee will provide all necessary instructions and address any queries that may arise.

#### <u> 12.- Prizes.</u>

Right after the conclusion of the Championship, a camaraderie meal will be organized for all participants and companions, during which the prizes and trophies will be awarded in accordance with the criteria outlined in number 4 rule.

#### 13.- Registrations.

The championship is open to active or retires police officers and military personnel. All participants must be affiliated and are required to submit a scanned, valid federation license along with their registration. Those without a federation license must apply for a one-day license, and the organization will handle the processing.

Participants using their own weapons must complete the necessary paperwork related to the Civil Guard Weapons Intervention to carry their municipal regulatory weapons.

Possession of a Federation License is mandatory for participation. Shooters lacking this license or those who haven't paid for the temporary license will not be allowed to participate.

This competition is part of the LIPOCAT Catalan Police Shooting League.

- The registration fee for IPA and/or LIPOCAT members is €35 (includes lunch)
  - A one-day license for non-federated participants carries an additional cost of €10.
- Non-member registration fee is €45 (includes lunch)
