Step 1 - Expression of Interest (until 31 January 2026)

At this stage, no participant details are required.

Step 2 - Submission of Participant Data (31 January - 15 February 2026)

After the first deadline, IPA Germany will request participant information from all sections that have expressed interest.

Allocation of Places

- Each IPA Section may register one participant.
- If not all seats are filled, additional participants from interested sections may be accepted.
- Final allocation depends on available capacity.

Media Consent Statement

By submitting the required registration documents, all participants give their consent that photo, video, and audio recordings may be taken during the event for official IPA purposes, including but not limited to documentation, reporting, internal communication, and public relations activities of IPA Germany and the international IPA community.
